

Welcome to GetTangi Corporation Privacy Policy

This privacy policy applies to all Personal Information collected by GetTangi Corporation.

When we refer to "**GetTangi Corporation**" or "**we**" or "**us**", we are referring to GetTangi Corporation and its associated global subsidiaries.

GetTangi Corporation recognizes the importance of your privacy, and that you have a right to control how your Personal Information is collected and used. We know that providing Personal Information is an act of trust and we take that seriously. Unless you directly give us consent to do otherwise, GetTangi Corporation will only collect and use your Personal Information as set out below.

## **What is Personal Information?**

Personal Information is information or an opinion (including information or an opinion forming part of a database), whether true or not, and whether recorded in a material form or not, about an individual whose identity is apparent, or can reasonably be ascertained, from the information or opinion.

## **How we collect Personal Information**

The main ways we collect Personal Information about you are:

1. when you register your information about on a GetTangi Corporation website, either by you or by a third party.
2. when you log into a GetTangi Corporation website or otherwise submit Personal Information to GetTangi Corporation.
3. when you contact GetTangi Corporation Support.
4. when you visit or use a GetTangi Corporation website, in which case our system automatically collects information relating to your visit to that website, such as your IP address.

You consent (and must procure that any relevant third-party consents) to the use of any Personal Information collected in relation to you (including, without limitation, any Personal Information contained in any Content provided) in accordance with the GetTangi Corporation Privacy Policy. If you include any personal information about another person in any Content you provide, you must:

(a) provide that person with a copy of the GetTangi Corporation Privacy Policy prior to providing us with that Personal Information; and

(b) where possible, have that person provide us with their Personal Information directly.

In addition, our other payment providers may collect Personal Information from you for the purposes of processing your Payment (for example, if you make a credit or debit card Donation, they may collect and hold your credit or debit card details).

For more information about how your Personal Information is collected, held, used, and disclosed, you should consult the website and/or privacy policy of all our payment processors.

### **What Information Do We Collect?**

When you register on GetTangi Corporation, the type of information that we collect from you may include the following: your name, phone number, location, address, e-mail address, organization name, job position/title, bank account details, business registration number, social security number, IP address, or your cookies.

### **Third party consent**

In addition, we may collect Personal Information when you have given your consent to another party who holds Personal Information about you to allow us access to that Personal Information.

For example, when you use PayPal to process credit and debit card payments, we may use the information that you provide to PayPal.

### **Why we collect, use, and disclose your Personal Information**

We may collect, hold, use, and disclose your personal information for the following purposes:

- to enable you to access and use our website and provide you with a service which you have requested.
- to operate, protect, improve, and optimize our website, business, and our users' experience, such as to perform analytics, conduct research and for advertising and marketing.
- to create an information database and associated content for use as part of GetTangi Corporation's online sales platform.

- to protect the rights, property or personal safety of another Tangi user, any member of the public or GetTangi Corporation.
- in a change of control event when any of the assets and/or operations of GetTangi Corporation are being transferred to another party; or
- other purposes described above or otherwise permitted by this policy.
- it is required or permitted by law (including by relevant privacy laws).

If you do not provide requested information, GetTangi Corporation may not be able to provide you with access to or full use of sections of the GetTangi Corporation website.

### **Disclosing Information**

GetTangi Corporation recognizes the trust you place in us when you share your Personal Information. To operate the Website and provide its associated services, GetTangi Corporation may sometimes share your Personal Information with its related entities, service providers, advisers, and other entities with whom GetTangi Corporation has a relationship, while operating the Website. Except as set out in this Privacy Policy, GetTangi Corporation will not otherwise disclose your Personal Information to other companies without your explicit consent.

Your information will be stored in our secure, firewalled database. As some of our service providers and subsidiaries are located outside of your country of residence, we may disclose personal information outside of said jurisdiction such as the EU and United States. When you provide your personal information to us, you consent to the disclosure of your information within and outside of your country of residence and acknowledge that we are not required to ensure that overseas recipients handle that personal information in compliance with your country of residence Privacy Law. We will, however, take reasonable steps to ensure that any overseas recipient will deal with such personal information in a way that is consistent with the Privacy Principles.

For clarity, the below lists several service providers that we use which may process your Personal Information:

- to process payments and to transfer funds to Social Ventures, we disclose your payment information to PayPal & others, who process payments globally.
- to optimize your experience, we may use data analytics providers
- to provide tailored e-mail marketing, we may use mail services that may have UK, EU, and US-based processing.

## **Marketing**

To give you the most worthwhile experience of the Website and its associated services as possible, GetTangi Corporation may use your Personal Information to send you information and product updates about the Website and its associated services. If you do not opt in for promotional and marketing emails, GetTangi Corporation will not send you advertising information not relating to the Website or its associated services.

We may also contact you at any e-mail or other address which we have collected or obtained to contact you about your profile or other Content such as reviews which you have posted on GetTangi Corporation website.

If you are receiving promotional or marketing information from GetTangi Corporation and do not wish to continue receiving this information, you may remove your name from our list by contacting the GetTangi Corporation Privacy Officer at [privacy@gettangi.com](mailto:privacy@gettangi.com) and asking to be removed from our mailing list or, in the case of emails, clicking the "unsubscribe" link at the bottom of the message. Please allow up to 5 working days for this request to be processed.

## **Access To the Information We Hold**

Changing and deleting the information we have about you

We will take all reasonable steps to change or delete information in response to such a request. If there is a reason that we cannot make that change or deletion, we will inform you of that reason.

## **Storage & Security of Your Personal Information**

GetTangi Corporation will endeavor to take all reasonable steps to keep secure any information which we hold about you, and to keep this information accurate and up to date. You should note that the internet is not a secure method of transmitting information and, as such, we are not responsible for the security of any information sent or received over the internet.

Please note that GetTangi Corporation may use overseas facilities including but not limited to the U.S and UK, to store, process or back up its information. As a result, we may transfer your personal Information to our overseas facilities. However, this does not change our commitment to keep your information secure.

### **Third Party Websites**

GetTangi Corporation websites may contain links to websites that are not operated by GetTangi Corporation and the contact details for these other organizations not operated by GetTangi Corporation. These linked sites are not under the control of GetTangi Corporation, and we are not responsible for the conduct of those organizations. Before disclosing your Personal Information on any other website or to any other organization, we advise you to examine the Terms and Conditions / Privacy Policy of those organizations.
